Following the passing of ordinary resolution approving the termination of the 2012 Share Option Scheme and the adoption of the 2021 Share Option Scheme at the Company's annual general meeting held on August 31, 2021, on September 6, 2021, The Stock Exchange of Hong Kong Limited granted the approval for the listing of, and the permission to deal in, the shares of the Company to be issued pursuant to the exercise of the options granted under the 2021 Share Option Scheme. Accordingly, the 2012 Share Option Scheme was terminated, and the 2021 Share Option Scheme was adopted, on September 6, 2021. In addition, following the passing of ordinary resolutions approving the amendments to the 2021 Share Option Scheme and the scheme mandate limit at the Company's annual general meeting held on August 30, 2023, the scheme mandate limit was amended from 2,683,678,641 to 2,158,059,212. Notwithstanding the foregoing, the outstanding share options under the 2012 Share Option Scheme will remain valid after the aforesaid termination.
